- The growth of the Malaysian healthcare providers market is driven by the mounting prevalence of chronic diseases such as hypertension, diabetes, and cardiovascular conditions. According to the National Diabetes Registry Report 2023 (the latest available official data), in 2023, there were 870,771 active diabetes patients in the NDR, with 99.5% diagnosed with Type 2 diabetes (T2DM), with 16.1% aged 65-69. This is increasing the demand for long-term medical care and, therefore, healthcare services.
