The market is segmented into inpatient care, outpatient care, long-term care, medical goods, and collective services and capital formation.
- The Taiwanese healthcare providers market recorded revenues of \$46.5 million in 2024, representing a compound annual growth rate (CAGR) of 4.4% between 2019 and 2024.
- The outpatient care segment accounted for the market's largest proportion in 2024, with total revenues of \$13.9 million, equivalent to 29.8% of the market's overall value.
- The growth of the Taiwanese healthcare providers market is driven by the mounting aging population. According to the Department of Household Registration, as of January 2024, 18.4% of the Taiwanese population, equating to 4.3 million, was over 65 years old. This is increasing the demand for long-term medical care and, therefore, healthcare services.
