- The medical goods segment accounted for the market's largest proportion in 2024, with total revenues of \$12.7 million, equivalent to 42.0% of the market's overall value.
- The growth of the Thai healthcare providers market is supported by increasing personal accident and health insurance, which expanded the pool of insured individuals and improved access to a wider range of health services. According to the Office of Insurance Commission, in 2024, the number of active personal accident and health insurance policies in Thailand reached 13.8 million, up 4.9% annually.
