Summary

Key Highlights

- The oil & gas market volume is defined as the total consumption (barrels of oil equivalent) of refined petroleum products and natural gas in each country in a specific year. The value of the oil segment reflects the total volume of refined petroleum products, including refinery consumption and losses, multiplied by the average retail price of gasoline and diesel taken together. The value of the gas segment is calculated as the total volume of natural gas consumed multiplied by the retail price of natural gas.
- The Singaporean oil & gas market recorded revenues of \$147.1 billion in 2024, representing a compound annual growth rate (CAGR) of 8.8% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 1.3% between 2019 and 2024, reaching a total of 592.6 million BoE in 2024.
- The Singaporean oil & gas market consumption volume grew by 1.3% in 2024, driven by rising industrial demand. The expansion of industrial activities across manufacturing, construction, and mining sectors has significantly boosted the need for fuel and energy. According to GlobalData, in 2024, the Nominal Gross Value Added (GVA) in Singapore's industry reached \$117.4 billion, reflecting a 4.5% increase from the previous year, driven by higher production requirements.
