The G8 countries are expected to reach a value of \$1,82,540.8 million in 2029, with a CAGR of 2.9% over the 2024-29 period.
- Among the G8 nations, the US is the leading country in the paper & paperboard industry, with market revenues of \$72,944.3 million in 2024. This was followed by Japan and Germany, with a value of \$25,129.1 and \$15,930.2 million, respectively.
- The US is expected to lead the paper & paperboard industry in the G8 nations with a value of \$84,853.4 million in 2016, followed by Japan and Germany with expected values of \$27,687.6 and \$16,948.6 million, respectively.
