- The European biotechnology market is experiencing unprecedented growth, fueled by a surge in equity financing and venture capital investments. According to the UK Bio Industry Association (BIA), in 2024, the UK?biotech and healthcare market saw an annual increase of 94% in equity financing, raising around GBP3.5 billion (\$4.4 million).
