- The Dutch casinos & gaming sector recorded gross gambling yield of \$3.1 billion in 2024, representing a compound annual growth rate (CAGR) of 1.7% between 2019 and 2024.
- The casinos segment accounted for the sector's largest proportion in 2024, with total gross gambling yield of \$1.7 billion, equivalent to 55.4% of the sector's overall value.
- The Dutch casinos & gaming sector held a 2.5% share of the total European sector share in 2024.
