The growth is attributed to the rising prevalence of lifestyle-related health issues such as obesity and cardiovascular diseases, prompting individuals to invest in gym memberships, personal training, and wellness programs to maintain a healthier lifestyle.
- The presence of substantial millennial and Gen Z populations, which are strongly focused on health, wellness, and personal fitness, supports the market growth. According to the US Census Bureau, in 2024, the Brazilian millennial and Gen-Z populations reached 50.5 million and 48.6 million, respectively.
