- The Brazilian paper & paperboard market recorded revenues of \$13.3 billion in 2024, representing a compound annual growth rate (CAGR) of 4.1% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 0.9% between 2019 and 2024, reaching a total of 9.6 million tonnes in 2024.
- The growth in consumption of paper and paperboard in Brazil during 2019-24 was driven by increasing literacy rates, a resurgence in physical book sales, and the expansion of the education sector. According to GlobalData, in 2023 (the latest available data), the Brazilian books market reached \$957.6 million, up 15.3% over 2019.
