- Market consumption volumes declined with a negative CAGR of 4.4% between 2019 and 2024, reaching a total of 15 million tonnes in 2024.
- The growth of the German paper and paperboard market is driven by rising e-commerce and online retail, which has significantly increased the demand for corrugated packaging solutions and containerboards. According to GlobalData, in 2024, the German online retail market reached \$102.5 billion, up 5.1% annually.
