- Market consumption volume increased with a CAGR of 1.0% between 2019 and 2024, reaching a total of 9.3 million tonnes in 2024.
- The growth of the South Korean paper and paperboard market is driven by rising e-commerce and online retail, which has significantly increased the demand for corrugated packaging solutions and containerboards. According to GlobalData, in 2024, the South Korean online retail market reached \$84.5 billion, up 3.9% annually.
