Market volume and value represents consumption volume and value.
- The Dutch paper & paperboard market recorded revenues of \$2.8 billion in 2024, representing a compound annual growth rate (CAGR) of 3.0% between 2019 and 2024.
- Market consumption volumes declined with a negative CAGR of 0.5% between 2019 and 2024, reaching a total of 2.6 million tonnes in 2024.
- The growth of the Dutch paper and paperboard market is driven by rising e-commerce and online retail, which has significantly increased the demand for corrugated packaging solutions and containerboards. According to GlobalData, in 2024, the Dutch online retail market reached \$24.5 billion, up 5.5% annually.
