Summary

Key Highlights

- Passenger rail sector consists of all passenger transport by rail services, including international, inter-city, regional, and suburban trains ("Commuter trains" in US terminology are included). However, tram/streetcar, metro/subway, and similar trains are not included.
- The French passenger rail sector recorded revenues of \$10,861.1 million in 2024, representing a compound annual growth rate (CAGR) of 4.8% between 2019 and 2024.
- The French passenger rail sector consumption volume increased with a CAGR of 3.8% between 2019 and 2024, reaching a total of 112.5 billion passenger kilometers (PKM) in 2024.
- In 2024, the French passenger rail sector grew by 11.9%, driven by a rise in travel and tourism. Increased domestic and international tourism led to higher demand for rail services, boosting ridership across the country. The expansion of high-speed trains and regional routes also contributed to this growth.
