- Among the G8 nations, the US is the leading country in the banks industry, with market revenues of \$23,506.7 billion in 2024. This was followed by France and Germany, with a value of \$14,381.8 and \$13,614.1 billion, respectively.
- The US is expected to lead the banks industry in the G8 nations with a value of \$31,001.3 billion in 2029, followed by France and Japan with expected values of \$18,402.9 and \$18,360.6 billion, respectively.
