- Within the banks industry, China is the leading country among the BRIC nations with market revenues of \$58,231.7 billion in 2024. This was followed by India, Russia and Brazil with a value of \$3,327.3, \$2,301.8, and \$1,994.1 billion, respectively.
- China is expected to lead the banks industry in the BRIC nations with a value of \$85,006.9 billion in 2029, followed by India, Russia, Brazil with expected values of \$6,269.9, \$4,750.8 and \$2,625.4 billion, respectively.
