The car manufacturing industry within the NAFTA countries had a total market value of \$338.6 billion in 2024. The Mexico was the fastest growing country, with a CAGR of 7.2% over the 2020-24 period.
- Within the car manufacturing industry, the US is the leading country among the NAFTA bloc, with market revenues of \$250.5 billion in 2024. This was followed by Mexico and Canada, with a value of \$60.2 and \$27.9 billion, respectively.
- The US is expected to lead the car manufacturing industry in the NAFTA bloc, with a value of \$286.0 billion in 2029, followed by Mexico and Canada with expected values of \$78.7 and \$33.3 billion, respectively.
