Additionally, the increasing use of sealants in electric vehicle (EV) manufacturing is further contributing to United Kingdom sealants market development as sealants ensure effective sealing of battery compartments, reduce noise, and enhance overall vehicle performance. The number of electric cars registered in 2023 reached nearly 315 ,000, which contributed to market growth as well.

The silicone-based resins are expected to dominate the market as they offer excellent durability, flexibility, and resistance to extreme temperatures. This makes them preferable in many industrial applications, such as building and construction of houses and offices. The demand for silicone sealants is further driven by other end-user industries, including the healthcare, electronics, locomotive, marine, and do-it-yourself (DIY) sectors.
