Report description:

The Vietnam pet food market size was approximately USD 129.93 Million in 2024. The market is estimated to grow at a CAGR of 9.10% between 2025 and 2034, reaching a value of USD 310.43 Million by 2034.

The Vietnam pet food market is in a developmental stage with countries like Japan entering into private pet food manufacturing agreements with local companies. This is because of the presence of non-restrictive regulatory laws for business outsourcing and low cost of manufacturing pet food. The United States of America, Cambodia, and China import a great variety of pet food products from Vietnam.

As per the Vietnam pet food market analysis, dog food sales accounted for more than half of the total market size in 2020. With the rising consumer disposable incomes and changing perception of pets as family members, pet ownership is expected to increase in the coming years. Moreover, there is a strong demand for mid-priced dog food in the country due to its affordability and the ability to meet the nutritional requirements of pets. Over the forecast period, the demand for premium dog food, including dog treats, is expected to record a significant uptick with the increasing awareness regarding pet care.

In 2020, cat food sales in Vietnam accounted for 35.6% of the total market size. Dry cat food dominated the overall category in food sales with more than 90% share, because of affordable pricing rates and convenience of serving.
