The Global Airport Baggage Handling System Market was valued at USD 9.2 billion in 2024 and is estimated to grow at a CAGR of 8.4% to reach USD 20.5 billion by 2034 driven by the rising air travel demand, along with the expansion of global air cargo and e-commerce logistics, is fueling market momentum. Among the system types, the conveying systems segment in the baggage handling market generated USD 3.5 billion in 2024, attributed to the rising demand for upgraded systems that are smarter, faster, and more reliable than their aging counterparts. As airports increasingly prioritize seamless operations, these modern conveyor setups offer substantial benefits-streamlining transfer times, minimizing delays, and significantly reducing instances of lost or mishandled luggage. With heightened pressure on airport operators to boost efficiency while cutting long-term maintenance costs, adopting advanced, energy-efficient conveying systems continues to accelerate, reinforcing their leadership position within the market.

By service type, the assisted service segment generated USD 5.5 billion in 2024, fueled by a growing emphasis on personalized travel experiences, prompting airports to cater to travelers who require or prefer human interaction, such as elderly passengers, premium travelers, or those handling oversized or sensitive luggage. While automation is becoming standard in baggage operations, hybrid models that combine digital tools with human support are gaining popularity. These blended service approaches not only enhance customer satisfaction but also help manage unexpected challenges more effectively, offering a balance between efficiency and empathy.

Several firms are expanding their regional manufacturing bases to overcome import cost hikes and meet localized demand.
