03-Apr-2025- Shell International Petroleum Co Ltd ESG plays a critical role in shaping its strategy as it transitions to a low-carbon future while maintaining energy security and economic performance. On the environmental front Shell has committed to becoming a net-zero emissions business by 2050 aligning with global climate goals. The company is investing in renewable energy sources such as offshore wind and has secured rights to develop 5 gigawatts of floating wind power off the Scottish coast. Shell is also advancing carbon capture and storage technologies and aims to ensure that 90 percent of UK drivers are within 10 minutes of a Shell electric vehicle charger by 2035. These efforts are part of its broader mission to reduce carbon intensity across its energy offerings. Socially Shell employs around 6000 people in the UK and emphasizes workforce safety diversity and inclusion. The company reports key safety indicators and has a total recordable case frequency of 0 point 8 per million hours worked. Shell supports gender diversity in leadership with women representing 28 percent of senior roles and engages with communities through education and entrepreneurship programs. In terms of governance Shell adheres to strict ethical standards through its General Business Principles and Code of Conduct. Its governance structure includes independent board members and executive oversight tied to sustainability goals. Transparency and compliance are further enforced through robust reporting systems and whistleblower mechanisms. Shell aligns its governance with international best practices to ensure accountability and trust. 86
