- The G8 countries contributed \$20,623.7 billion in 2024 to the global government spending industry, with a compound annual growth rate (CAGR) of 2.5% between 2020 and 2024. The G8 countries are expected to reach a value of \$24,928.4 billion in 2029, with a CAGR of 3.9% over the 2024-29 period.
- Among the G8 nations, the US is the leading country in the government spending industry, with market revenues of \$11,172.7 billion in 2024. This was followed by Germany and France, with a value of \$2,207.5 and \$1,785.6 billion, respectively.
- The US is expected to lead the government spending industry in the G8 nations with a value of \$13,825.0 billion in 2029, followed by Germany and France with expected values of \$2,678.1 and \$2,062.2 billion, respectively.
