Shortage of Skilled Dental Professionals

The Danish dental care market faces a growing challenge in balancing increasing service demand with limited availability of trained dental professionals. The shortage of specialists, including orthodontists and periodontists, restricts the availability of certain procedures and slows treatment delivery. Recruitment and retention difficulties in rural and semi-urban regions further exacerbate these operational constraints, hindering service expansion and creating disparities in care accessibility across the country.
