- Construction market includes both residential and non-residential construction. Market value refers to the total output value of construction activity in a specific year. Construction output value is defined as the total value of construction activity in any given period, including costs related to all materials, equipment, and services used.
- The Argentinian construction industry recorded revenues of \$41.1 billion in 2024, representing a compound annual growth rate (CAGR) of 4.8% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$25.1 billion, equivalent to 61.1% of the industry's overall value.
- The Argentinian construction industry recorded a contraction in market value in 2024 when measured in US dollars, despite experiencing growth in local currency terms. The expansion of the Argentinian construction industry in 2024 in local currency terms was largely driven by the continued growth of the urban population. According to the World Bank, the proportion of urban population in Argentina reached 92.6% in 2024, pressuring city planners to accelerate housing and transport development.
