Summary

- Construction market includes both residential and non-residential construction. Market value refers to the total output value of construction activity in a specific year. Construction output value is defined as the total value of construction activity in any given period, including costs related to all materials, equipment, and services used.
- The Danish construction industry recorded revenues of \$59.6 billion in 2024, representing a compound annual growth rate (CAGR) of 6.0% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$35.0 billion, equivalent to 58.8% of the industry's overall value.
- In 2024, the Danish construction industry recorded an annual growth of 2.9%. The growth is bolstered by ambitious housing targets. Initiatives under the National Housing Plan are supporting the industry's expansion, particularly in urban centers such as Copenhagen and Aarhus. According to Statistics Denmark, in Q4 2024, the housing starts in Denmark reached 2,757 units, up from 2,315 units in Q3 2024.
