- The Indian construction industry recorded revenues of \$861.3 billion in 2024, representing a compound annual growth rate (CAGR) of 9.9% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$603.1 billion, equivalent to 70.0% of the industry's overall value.
- In 2024, the Indian construction industry recorded an annual growth of 8.1%. The growth is attributed to the rise in household consumption expenditure on housing, driving residential construction activities. According to the MOPSI, in 2024, the final household consumption expenditure on housing per household in India reached \$1,218.7, up 7.8% annually.
