- Construction market includes both residential and non-residential construction. Market value refers to the total output value of construction activity in a specific year. Construction output value is defined as the total value of construction activity in any given period, including costs related to all materials, equipment, and services used.
- The Irish construction industry recorded revenues of \$27.9 billion in 2024, representing a compound annual growth rate (CAGR) of 0.8% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$17.2 billion, equivalent to 61.7% of the industry's overall value.
- In 2024, the Irish construction industry recorded an annual growth of 1.8%. The growth is attributed to rising household consumption expenditure on housing, leading to a steady rise in homeownership and construction. According to the Central Statistics Office of Ireland, in December 2024, the existing home sales in Ireland reached 3,810 units, up from 2,810 in January 2024.
