- Construction market includes both residential and non-residential construction. Market value refers to the total output value of construction activity in a specific year. Construction output value is defined as the total value of construction activity in any given period, including costs related to all materials, equipment, and services used.
- The Mexican construction industry recorded revenues of \$269.6 billion in 2024, representing a compound annual growth rate (CAGR) of 11.7% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$213.1 billion, equivalent to 79.0% of the industry's overall value.
- In 2024, the Mexican construction industry recorded an annual growth of 3.4%. The growth is attributed to rising household consumption expenditure on housing, either through the development of new homes, renovations, or upgrades. According to the Organization for Economic Co-operation and Development (OECD), in 2024, the final household consumption expenditure on housing per household in Mexico reached \$9,534.3, up 11.8% annually.
