Summary

- Construction market includes both residential and non-residential construction. Market value refers to the total output value of construction activity in a specific year. Construction output value is defined as the total value of construction activity in any given period, including costs related to all materials, equipment, and services used.
- The Norwegian construction industry recorded revenues of \$72.0 billion in 2024, representing a negative compound annual growth rate (CAGR) of 0.2% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$45.5 billion, equivalent to 63.2% of the industry's overall value.
- In 2024, the Norwegian construction industry recorded an annual contraction of 4.9%. The contraction is attributed to the fall in residential construction activities. The demand for new housing experienced a downturn, influenced by factors such as higher interest rates, inflation, and economic uncertainty, which deterred both developers and homebuyers.
