Construction output value is defined as the total value of construction activity in any given period, including costs related to all materials, equipment, and services used.
- The Peruvian construction industry recorded revenues of \$38.8 billion in 2024, representing a compound annual growth rate (CAGR) of 5.5% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$28.5 billion, equivalent to 73.6% of the industry's overall value.
- The expansion of the Peruvian construction industry in 2024 was primarily supported by the steady growth of urban populations, particularly in cities like Lima, Arequipa, and Trujillo. Rising internal migration and demographic shifts led to a surge in demand for commercial spaces, industrial facilities, and public infrastructure upgrades. According to the World Bank, the proportion of urban population in Peru reached 79.1% in 2024, pressuring city planners to accelerate housing and transport development.
