- The Filipino construction industry recorded revenues of \$71.1 billion in 2024, representing a compound annual growth rate (CAGR) of 2.3% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$48.6 billion, equivalent to 68.4% of the industry's overall value.
- In 2024, the Filipino construction industry recorded an annual growth of 8.5%. The growth is attributed to the significant progress in infrastructure development. For instance, the Department of Public Works and Highways (DPWH) completed 11,945 kilometers of road projects between July 2022 to May 2024.
