Summary

### Key Highlights

- Construction market includes both residential and non-residential construction. Market value refers to the total output value of construction activity in a specific year. Construction output value is defined as the total value of construction activity in any given period, including costs related to all materials, equipment, and services used.
- The Polish construction industry recorded revenues of \$178.5 billion in 2024, representing a compound annual growth rate (CAGR) of 8.4% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$149.6 billion, equivalent to 83.8% of the industry's overall value.
- In 2024, the Polish construction industry recorded an annual growth of 8.8%. The growth is attributed to the rise in homeownership and, therefore, building permits for construction. According to the Central Statistical Office of Poland (GUS), in December 2024, the residential building permits in Poland reached 79,100, up from 5,340 in January 2024.
