Summary

Key Highlights

- Construction market includes both residential and non-residential construction. Market value refers to the total output value of construction activity in a specific year. Construction output value is defined as the total value of construction activity in any given period, including costs related to all materials, equipment, and services used.
- The Czech construction industry recorded revenues of \$58.1 billion in 2024, representing a compound annual growth rate (CAGR) of 7.0% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$48.2 billion, equivalent to 82.9% of the industry's overall value.
- In 2024, the Czech construction industry recorded an annual contraction of 1.8%. The contraction is attributed to a decline in residential construction activity due to a slowdown in new housing permits. According to the Ministry of Ecology, in December 2024, the housing building permits in the Czech Republic reached 5,070, down from 6,200 in December 2023.
