- The UK construction industry recorded revenues of \$535.3 billion in 2024, representing a compound annual growth rate (CAGR) of 4.4% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$296.3 billion, equivalent to 55.3% of the industry's overall value.
- In 2024, the UK construction industry recorded an annual growth of 4.7%. The growth is attributed to robust public infrastructure investment and ambitious housing targets. Projects such as HS2 and upgrades to the National Grid are supporting the industry's growth.
