- The US construction industry recorded revenues of \$2,529.3 billion in 2024, representing a compound annual growth rate (CAGR) of 7.9% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$1,433.4 billion, equivalent to 56.7% of the industry's overall value.
- The growth of the US construction industry during 2019-24 was strengthened through government investments focused on improving infrastructure. For instance, the Bipartisan Infrastructure Law (2021) allocated over \$1.2 trillion to upgrade roads, bridges, public transit, water systems, and broadband networks.
