Construction output value is defined as the total value of construction activity in any given period, including costs related to all materials, equipment, and services used.
- The Vietnamese construction industry recorded revenues of \$95.8 billion in 2024, representing a compound annual growth rate (CAGR) of 7.8% between 2019 and 2024.
- The non-residential segment accounted for the industry's largest proportion in 2024, with total revenues of \$61.2 billion, equivalent to 63.8% of the industry's overall value.
- In 2024, the Vietnamese construction industry recorded an annual growth of 4.6%. The growth is attributed to the rise in foreign and domestic investment in Vietnam's industrial real estate sector. Manufacturing-led FDI inflows, particularly from electronics and textile sectors, spurred the development of industrial parks, warehouses, and export processing zones across provinces such as Bac Ninh, Binh Duong, and Long An.
