- The healthcare segment accounted for the market's largest proportion in 2024, with a total expenditure of \$13.4 billion, equivalent to 13.0% of the market's overall expenditure.
- In 2024, the Singaporean government spending market experienced an annual growth of 6.1%, partly due to increased pressure on urban infrastructure and environmental systems. Despite its compact size, Singapore's total population reached 6.04 million in June 2024, marking a 2.0% increase from June 2023, according to the Department of Statistics Singapore.
