Summary

Key Highlights

- Motorcycles market includes all on- and off-road motorcycles including scooters and mopeds. Mopeds are two-wheeled vehicles with an engine capacity of less than 50cc. They are generally equipped for both motorized and non-motorized propulsion and have a restricted maximum speed. Any powered two-wheeler that is not a moped is classified as a motorcycle (The term 'scooter' refers to a two-wheeler of any capacity that has its engine as part of the rear suspension and/or has a step-through chassis. Depending on its engine capacity, a scooter may be classified as either a moped or a motorcycle).
- The South African motorcycles market recorded revenues of \$148.9 million in 2024, representing a compound annual growth rate (CAGR) of 3.6% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 7.3% between 2019 and 2024, reaching a total of 29.2 thousand units in 2024.
- The growth of the South African motorcycles market volume in 2024 was primarily driven by the increase in disposable income. Rising wages boosted motorcycle purchasing, resulting in increased vehicle registrations and a shift from public transport to personal mobility among a broader population. According to Eurostat, in 2024, the net household disposable income in South Africa reached \$202.8 billion, marking a 5.2% increase over 2023.
