- Market consumption volume increased with a CAGR of 2.8% between 2019-24, reaching a total of 273.6 million units in 2024.
- The healthy market growth observed during 2019-24 was primarily driven by the rising urban population, surge in disposable income of individuals, and increasing purchasing power.
