The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2024 exchange rates.
- The Japanese Skincare market recorded revenues of \$13,951.3 million in 2024, representing a negative CAGR of 5.5% between 2019-24.
- Market consumption volumes declined with a negative CAGR of 0.2% between 2019-24, reaching a total of 1,180.7 million units in 2024.
- The Japanese skincare market contracted during 2019-24 was largely influenced by the unfavorable economic conditions, decline in consumers' disposable income, and decrease in consumer expenditure on non-essential commodities.
