- The skincare market consists of the retail sale of facial care, body care, hand care, depilatories, and make-up remover products. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2024 exchange rates.
- The Dutch Skincare market recorded revenues of \$662.0 million in 2024, representing a compound annual growth rate (CAGR) of 3.3% between 2019-24.
- Market consumption volume increased with a CAGR of 0.1% between 2019-24, reaching a total of 86.8 million units in 2024.
- The moderate market growth observed during 2019-24 was primarily due to shifting consumer behaviour and increased consumer spending power.
