Summary

- The wine market consists of the sale of still wine, sparkling wine, and fortified wine. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using the constant annual average 2024 exchange rates.
- The Canadian Wine market recorded revenues of \$9,932.4 million in 2024, representing a negative compound annual growth rate (CAGR) of 0.8% between 2019-24.
- Market consumption volumes declined with a negative CAGR of 1.6% between 2019-24, reaching a total of 540.4 million liters in 2024.
- Decline in wine drinking population, and strong growth in demand for ready-to-drink alcoholic beverages have contributed to the sluggish growth of the Canadian wine market during 2019-24.
