- Market consumption volumes declined with a negative CAGR of 1.3% between 2019-24, reaching a total of 2,531.7 million liters in 2024.
- The French wine market recorded sluggish growth during 2019-24 due to consumers spending less money on non-essential products amid escalating living expenses and economic instability.
