- The South African Wine market recorded revenues of \$1,034.0 million in 2024, representing a negative compound annual growth rate (CAGR) of 3.9% between 2019-24.
- Market consumption volumes declined with a negative CAGR of 1.5% between 2019-24, reaching a total of 367.6 million liters in 2024.
- The South African wine market recorded sluggish growth during 2019-24 due to the unfavorable economic conditions, surge in inflation, and decline in purchasing power of consumers.
