- Within the automotive manufacturing industry, China is the leading country among the BRIC nations with market revenues of \$471.1 billion in 2024. This was followed by India, Brazil and Russia with a value of \$97.0, \$66.1, and \$25.4 billion, respectively.
- China is expected to lead the automotive manufacturing industry in the BRIC nations with a value of \$629.4 billion in 2029, followed by India, Brazil, Russia with expected values of \$132.9, \$91.4 and \$34.7 billion, respectively.
