- The automotive manufacturing industry is segmented into car manufacturing, motorcycle manufacturing, and truck manufacturing. The electric and hybrid vehicles are out of our market scope.
- The Canadian automotive manufacturing industry recorded revenues of \$68.9 billion in 2024, representing a negative compound annual growth rate (CAGR) of 4.7% between 2019 and 2024.
- Industry production volumes declined with a negative CAGR of 6.2% between 2019 and 2024, reaching a total of 2.4 million units in 2024.
- The production volume of Canadian automakers saw a notable contraction of 10.3% in 2024, primarily due to ongoing supply chain volatility and labor availability issues. Disruptions in cross-border logistics, particularly for US-sourced components, resulted in production delays at plants in Windsor and Oakville.
