- The Polish automotive manufacturing industry recorded revenues of \$19.3 billion in 2024, representing a compound annual growth rate (CAGR) of 5.5% between 2019 and 2024.
- Industry production volumes declined with a negative CAGR of 0.3% between 2019 and 2024, reaching a total of 0.6 million units in 2024.
- The Polish automotive manufacturing industry's production volume grew by 2.3% in 2024, which was supported by rising demand from the domestic rental car market. Fleet expansion by rental companies led to bulk orders, boosting factory output. According to GlobalData, the rental car fleet in Poland stood at 41,573 units in 2024, an increase of 9.8% from the previous year.
