- The growth of the hybrid & electric cars market in 2024 was driven by high fuel prices, advancements in battery technologies, and supportive federal investments. According to
- INSEE, the gasoline price in France increased by 4.3% in December 2024 as compared to December 2023, influenced by rising crude oil costs, carbon pricing policies, and regional fuel regulations.
