Passenger cars include saloons/sedans, hatchbacks, SUVs, 4x4s, and other related vehicles. Market value is calculated at the retail selling price (RSP) and the market volume is given in terms of units sold.
- The Turkish hybrid & electric cars market recorded revenues of \$7,076.7 million in 2024, representing a compound annual growth rate (CAGR) of 80.3% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 74.4% between 2019 and 2024, reaching a total of 189,954.0 units in 2024.
- In 2024, the hybrid & electric cars market in Turkey experienced growth due to soaring fuel prices. Gasoline prices saw a significant rise due to the Special Consumption Tax (SCT), surpassing TRY43 (\$1.3) per liter by April 2024, which represented a 113% increase from the previous year.
