Market volume represents the number of internet users in a specific country in a year.
- The Asia-Pacific internet access market recorded revenues of \$327,427.1 million in 2024, representing a compound annual growth rate (CAGR) of 6.5% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 7.2% between 2019 and 2024, reaching a total of 3,086,555.5 thousand internet users in 2024.
- China accounted for the largest share of 82.6% of the Asia-Pacific internet access market in 2024.
