- The Canadian internet access market recorded revenues of \$11,300.5 million in 2024, representing a compound annual growth rate (CAGR) of 5.4% between 2019 and 2024.
- Market consumption volume increased with a CAGR of 2.1% between 2019 and 2024, reaching a total of 37,639.3 thousand internet users in 2024.
- Canada accounted for a share of 8.9% of the North American internet access market in 2024.
